lately made, as the sum of *Fourteen* Dollars and *eighty* Cents,

which to the said *Sanford Loan & Trust Company, a Corporation*

lawful interest on said damages from the rendition of said judgment till paid, and the cost of this writ

and your proceedings hereon, and that you have the said sum of money before the Judge of our said
