It is therefore ordered and adjudged that the plaintiff the Sanford Loan & Trust Company a Corporation of the State of Florida do have and recover of and from the defendant E. C. Lanier the sum of \$96.<sup>34</sup> as its damages as well as the further sum of \$14.<sup>80</sup> as its cost in this behalf expended.
