1.

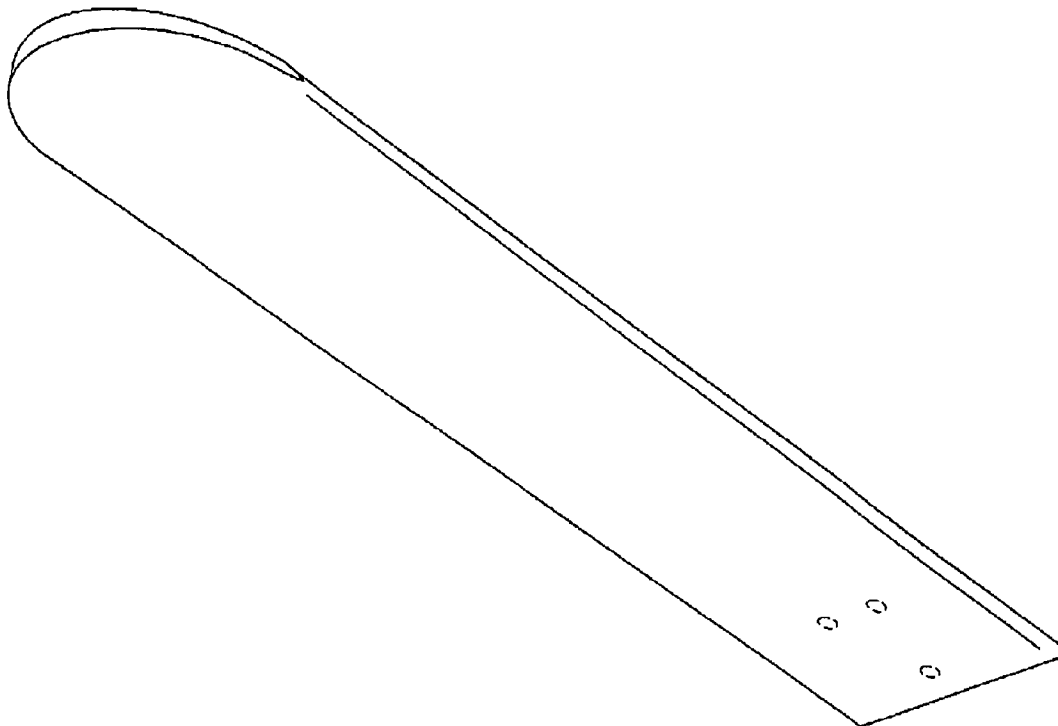
The broken line showing of the mounting holes is included for

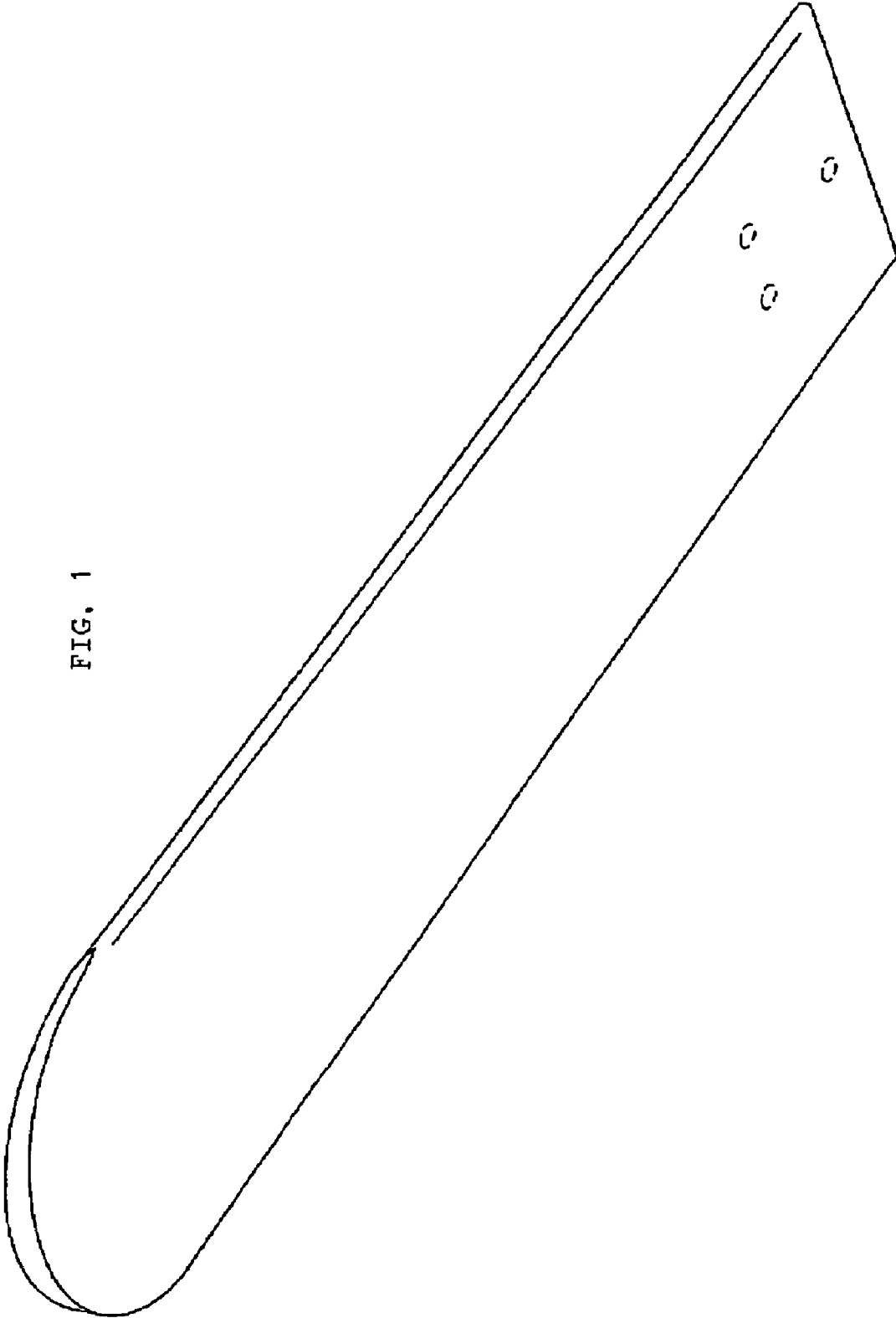

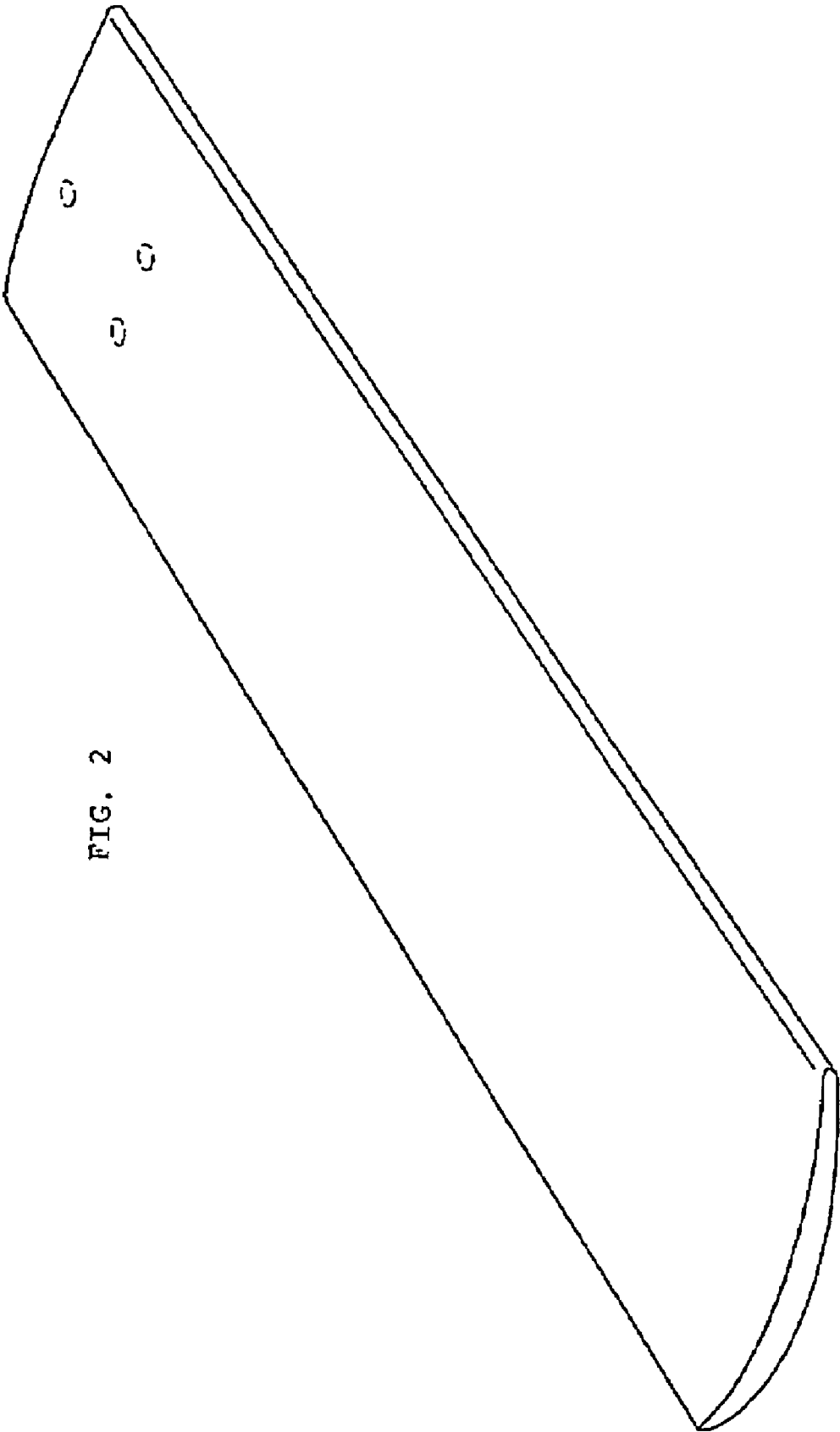
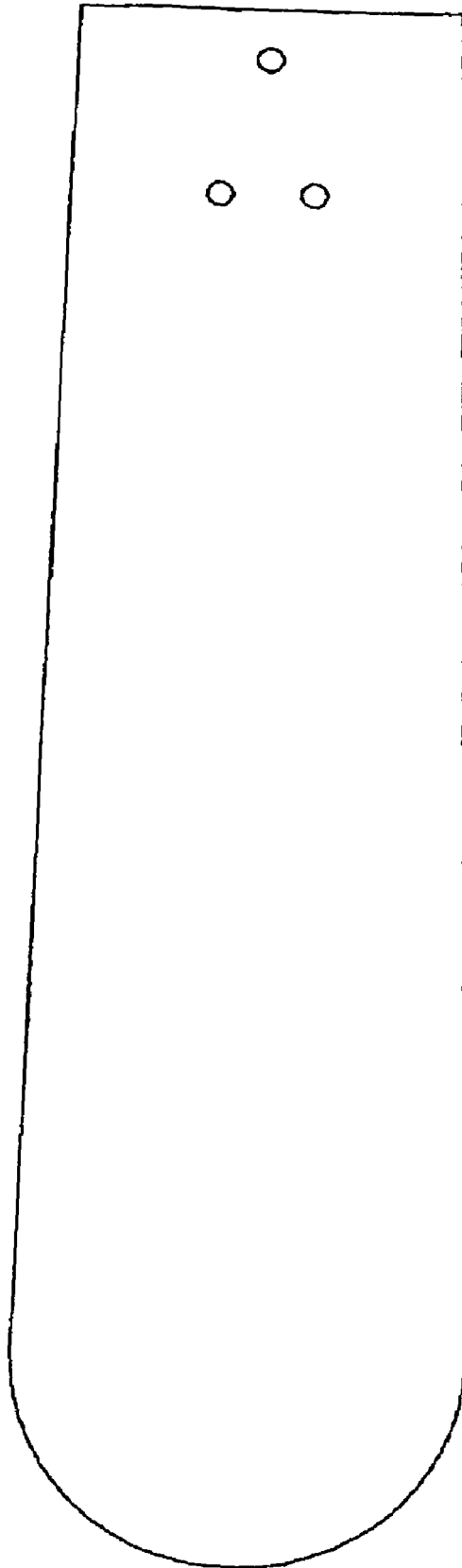

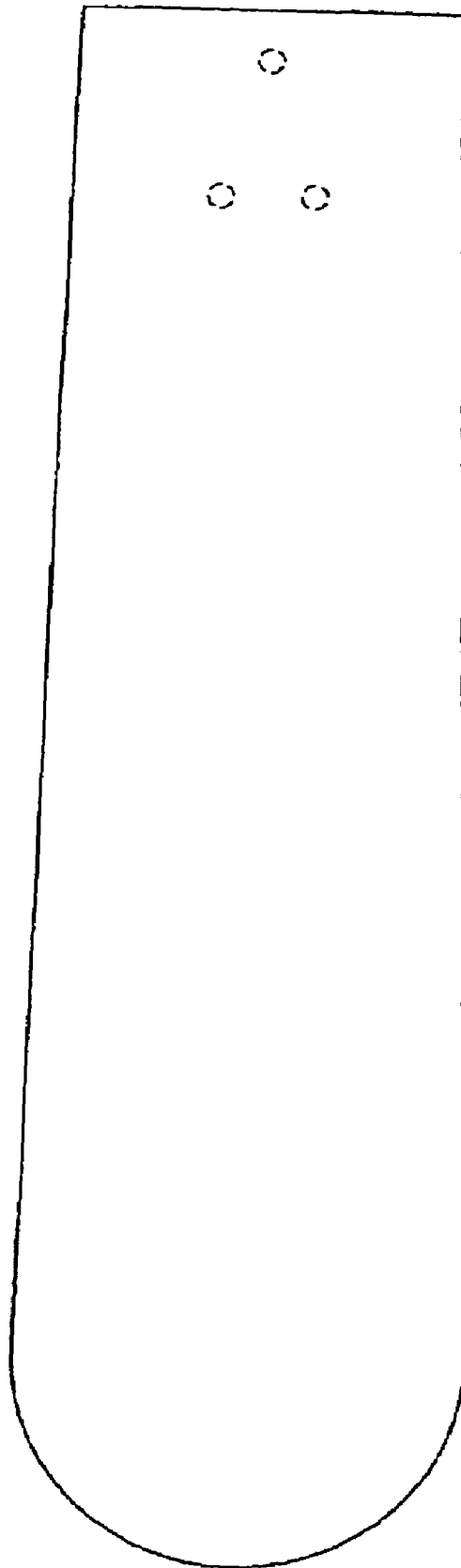

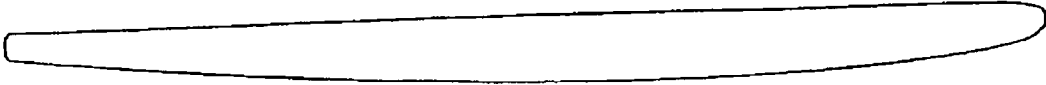

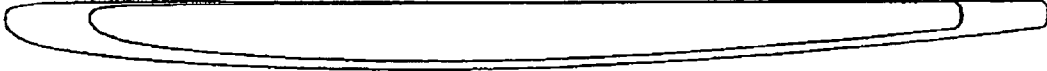
