INSTRUCTIONS FOR DISTRICT REGISTRATION OFFICERS

PRIMARY ELECTION REGISTRATION 1934

PERSON ENTITLED TO REGISTER. Only those persons who are over the age of 21 and who have lived in the State one year and the County six months may register

BOUNDARIES. The boundaries for your precinct will be found on map pasted in front of cover of book

APPLICANTS FOR REGISTRATION MUST FIRST BE EXAMINED as to their residence address. If the applicant lives within the bounds of your precinct and is otherwise qualified or entitled to register, then proceed to swear him by having him take the oath printed at the top of registration book and then enter in the registration book and on the registration certificate all the information required.

ELECTION DISTRICT is your precinct number shown on your registration book. Be sure to show precinct number on registration certificate.

NUMBER CERTIFICATES FROM ONE UP except the last few in your pad. If you spoil a certificate tear an unnumbered certificate out of back of pad and give it the number of the spoiled certificate. Enter the number of certificate in proper column on registration book.

NAME. Write surname first and given name last. Register women by given name, as SMITH, MARY, and not Mrs. John Smith.

POLITICAL PARTY. Be very careful to write the name of the party affiliation plainly. Dem. for Democrat, Rep. for Republican. If a person refuses to give his party affiliation, refuse to register him. It's the LAW.

VOTED. Ignore this column. It does not concern registration.

POLL TAX. Ignore this column. This will be filled in by the Supervisor of Registration's office after the books are returned.

EXEMPTION. Only the following are exempt from Poll Tax: Those who are just 21; those who were 55 on or before the 1st day of January, 1932; World War and Spanish American War Veterans who are drawing a Service Connected Disability Compensation; Members of the National Guard; and those who have lost a limb in battle or through misfortune.

AGE. Require everyone to give correct age.

RESIDENCE. Be sure to show residence address or rural delivery box number etc.

SIGNATURE OF ELECTOR. Be sure to have each applicant sign the book.

BOOKS SHOULD BE KEPT OPEN each week day from 9 A.M. to 12 Noon, and from 2 P.M. to 5 P.M. and one night each week until 9 P.M.

NOTICES. Post the notices in at least three conspicuous places in the district stating when and where the books are kept open

BRING BOOKS IN TO REGISTRATION office on Tuesday, April 3rd, 1934. If for any reason you cannot bring the books in, notify the Supervisor of Registration and they will be sent for. They must be returned on that day.

If in doubt about anything, get in touch with the office of the Supervisor of Registration.
