Meeting called to order at 9:30 a.m. by President Debbie Pope.

1. Welcome/Updates

Debbie welcomed all members, guests and new member Stacey Royalty Rose.

2. Approval of Minutes

- o Trisha Trovillion moved to accept the minutes for September and Cissy Glowth seconded the motion. Minutes were approved for the September 15th meeting.

3. Roll Call Attendance: Sign in sheet in lieu of roll call.

4. Human Resource Updates – Michelle Brooks – Assistant Director, Employee Relations - Human Resources (HR)

- o The AFSCME Collective Bargaining meeting was September 22, 2016. Offer included a 1% salary increase and a 1.5% discretionary raise agreement on the wages article and it will not be retroactive. Unable to advise regarding the time that has passed from when non-unit increases went into effect.
- o Discretionary Raise: The guidelines are on the Human Resources web site.
- o Fair Labor Standards Act (FLSA): Federal law for payment of over time will be effective December 1st. If the employee makes less than \$47,476 annually they will be considered non-exempt and earn overtime (this will also apply to A & P employees).
- o The employee will be contacted by Human Resources of the FLSA changes and all non-exempt employees are required to submit a time card documenting their hours. More information on the FLSA can be found on the HR website.
- o Open enrollment starts on October 17th and ends on November 4th.
- o Benefits Fair is October 28th from 9 a.m. to 2 p.m.
- o There is no information on the Christmas shut-down at this time.

- o Danielle Frazier has resigned her position at UCF and Maribel Amaro-Garcia will now be taking care of the USPS Facebook page.

- Flyers for the Benefit's Fair have been completed.

 - ❖ Special Events/Diversity Committee
