to give thee the salutation; of abiding love, thou

I can do mouth or lay forth at this time, therefore
thou my salutation is true, for my love doth truly flow
to thee wth at this season & not at this only but at
many other times, but I am in hopes thy time draws on
I may have a more full enjoyment of thee wth is much
desired, when the Lord shall see so to order it, & in thy
mean time I shall be contented in those enjoyments, I
have of thee, my wife doth also salute thee wth her
endearing love, she was delivered of a girl thy 13 of the
last past 'tis a lovely child comes on very well, & so happy
phoebe my father & mother are both well & thy rest of the
family & their love is to thee my father intends to be at

she knows not of my writing but I know her love is to

thy 20th mo 1679 I laid afore him his own
goods but he told me no way how I should get my
goods but to deposit thy 13th wth I could not, I from
went to Hillon who wrote a letter to him to
come to fore him & bring wth him (one) but I would
not go, I went to manlyke, the gossions being
the same week & there laid his Auction before
thy 20th mo, & they did reprove him pretty much but
would not order my goods back wth and I would pay
money wth I would not, my goods were freely given
up not having any expectation to get them again

who writ a letter to him to come before him & bring wh him (me) but

reprove him pretty much but would not order my goods back without
I would pay ye moneys, wh I would not, my goods were freely gone &
& not having any expectation to get them againe only I was unwill-
ing such base actions should lye hidden undiscovered to ye magis-
trates it was layd before ye sessions on 7th day & on 3day after
they of the Inn turned out the cow & shee came home & I have had
her ever since the ostler at ye Inn says she turned her out for he
could not get her either to eate hay or drink water only a little
drafft & if they had kept her shee would have beene deade quickly,
but since I red her shee mends againe & does well/ they have not
got into my fathers as yet altho Townley has beene there several
times I told Hilton how I got my cow againe, he replied the cow
had more wit than Townley

I would have thee remember my true love to Wilm Gibson
& tell him if I had thought he would have miscalled my letter I
would have given him a shorte acct of H. Baly's denial of the bill
I writ no more than what I tooke the heads of from H. B.: owne
mouth in writing, therefore altho it's my writing it's H. B: Apol-
ogy, & not ansr my letter intimates the same where I say he refuses
to accept the bill for ye following reasons, therefore being I am
cleare from making any pty (party) in ye matter, I desire not to
be brought in whether I will or not, for what I did was (littel or)
no more yt (that) I know of but what he desired from my father, in,
lawJ Clarke desires to be remembered to thee, wh is all at present
but am thy friend & Brother in ye truth phinehas pemberton
