ROOMS online

The John C. Hitt Library is proud to announce the launch of the joint Faculty/Graduate Study Room service this Fall Semester. The library has a total of 11 study rooms that can accommodate between 2 to 10 people. The study rooms are located on the third floor of the library and may be checked out by any faculty, on a first-come, first serve basis. The study rooms can be checked out for a total of four hours. This service provides the faculty with the opportunity to meet with their students outside their regular office. Reservations can be made up to 7 days in advance online. Springer is a major publisher of academic and professional books and series. Their eBooks are suitable for research, study, and course projects, and can be assigned as textbooks. The UCF Library has perpetual rights and online access to Springer books published in English between 2005 and 2014, comprising of over 16,000 volumes. In addition, UCF users have access from 1997 to 2014 to all of Springer's major book series, including the well-known Lecture Notes Series. Springer eBooks are available to all UCF students, faculty and staff anywhere, anytime. Because Springer eBooks are in PDF format, students can print, e-mail, and download entire chapters and books to read off-line on a cell phone, eBook reader (such as Kindle), laptop, or any computer. Many of the titles are suitable as textbooks and faculty may choose to replace or supplement their main textbooks with Springer eBooks. There is no limit on the number of people who can open Springer eBooks at one time, and any fair use of the content for educational purposes is allowed, including embedding the content in Canvas. Students who are content to use the eBooks may not need to buy a copy of the text. Students that prefer print may order a rapid-print copy of any of the Springer titles which will be bound and shipped to their address for \$25. This convenient resource is an excellent way for faculty and students to contribute to the teaching and research mission of UCF without purchasing textbooks. Interlibrary Loan & Document Delivery Services for UCF Patrons-Kristine J. Shrauger

Interlibrary Loan is the borrowing and lending of materials between libraries. You may request books, articles, DVDs, CDs, etc. that are not owned by the UCF Libraries, and the department will obtain them from other libraries or document suppliers. **Document Delivery Services** provides UCF library materials to faculty, staff, graduate students, regional campus patrons and distance learners. You can submit a request to the department for items that are owned by UCF Libraries and the department will pull the book or DVD and route it to the circulation desk of your home institution (or mail it directly to the home address of distance learners). Articles will be scanned and sent to your ILLiad account.

If you have used ILL/DDS in the past, you will notice that things have changed over the summer. ILLiad, which is the system for ordering books and articles, has migrated to single sign-on. You will no longer need to remember your PID and ILL password.
