To Gerard & Charles Houghton
members of the house of commons

On the behalfe of our selves, whose names are under
written and many others of our suffering friends in
this County of Lancashire we make & apply
unto you the Representatives of the County members
of Parliament, acquainting you that we are very
great sufferers, upon the Statutes made Against
Popish Religiants, in Queen Elizabeth & King James
times; & of most heinous oppression lay upon us
the truth sake & exercise of o^r Conscience to
God by the late Act made against Conventicles.
As also great sufferings by Imprisonment and
spoiling of o^r goods in the case of Swearing and
Tythes; in which we have a testimony for God;
we humbly Request you to weigh our deep suffer-
ings, & that you would be pleased to move in
Parliament for o^r Relief, that these heinous and
most unchristian & burdens & sufferings, we are
daily exposed unto, and are oppressed, and we may
be eased off; which we hope you yo^r selves will
Judge to be very Equall; we neither bring Paynt
nor Popishly affected, that we should not suffer by
Laws made against them, whose principles and
Practices we deny, and that o^r yea & nay might
be taken in stead of an oath, in that depending to
Christs doctrine we cannot Swear at all, as also if
we might be eased of this great oppression and
deep suffering of & Conventicle tythes; these are
some of the most weighty of o^r Grievances, which
under present sense of our great sufferings we lay
before you, in hopes of Redress. We not desiring
to be tedious to you, take leave, & Rest.
