Faculty assembly

Parking fee increases likely

Money would help build 1,000-car garage; construction could begin in December '93

Senior university officials are considering a recommendation to raise parking fees to speed construction of a 1,000-car parking garage while interest rates remain low.

Additional funding generated by the increase would add enough dollars to the university's parking garage trust fund to

tap the bond market sooner than originally anticipated. The fund now stands at about \$500,000, and the new rate structure would increase the balance by about \$200,000. The \$700,000 might be sufficient to go to the bond market and get good rates for building a \$5 million parking garage, although \$1 million in hand would be more advisable, said John Bolte, vice president of administration and finance.

Because of "favorable" interest rates and the low bids characteristic of the local construction climate, UCF may decide to move ahead with the project despite being shy of the \$1 million figure. If all goes as planned,

construction could begin as early as December 1993, Bolte said.

According to Bolte, the state does not adequately fund

new parking on campus when buildings are constructed. Therefore, the parking garage must be funded with decal fees, he said. Bolte said the decal fees have increased during the last three years

because they are the only source of funds authorized by the state for maintenance and repair of campus parking areas and are the primary source of funds for new campus parking lots and facilities.

If the next proposed increase is accepted, parking fees would increase in the fall. Reserved parking would be an additional \$20, to \$225; faculty parking would go up \$6, to \$66; students and staff employees would pay \$40, an increase of \$4; and motorcycle parking would increase \$1, to \$13 a year. Currently, UCF's parking fees are near the middle range of other universities in the State University System, Bolte said.

Bryan says good-bye to university

Robert Bryan, in his last public address as interim president of UCF, praised university employees and said his time here was "very special."

Speaking to an estimated 200 university and community leaders at a farewell luncheon on Feb. 27, Bryan said, "It's been a wonderful time here. Thank you very much for the

special memory ... I didn't realize I'd have as much fun as I have when I came down here."

Bryan served as interim president for eight months. John Hitt, who was at the luncheon, assumed presidential duties March 1. Also attending were former UCF presidents Charles Millican and

Trevor Colbourn.

"It's been very special," Bryan said. Then addressing Orlando Mayor Bill Frederick, he added: "I've felt as much at home here as I did in Gainesville ... except for the traffic."

Bryan then praised UCF's faculty

Subject: Operational changes in building services

As a service organization, the physical plant must continually evaluate its capability to efficiently provide the best possible service. The personnel hiring freeze resulting from recent budget cuts has effected our ability to provide the quality of cleaning services we would prefer. Currently, 18 percent of the positions in building services are vacant and cannot be filled because of the hiring freeze. In addition, the absenteeism rate for the department is averaging at least 6 percent each day. The combination of these two items results in an average daily reduction in the building services work force of approximately 24 percent.

In an effort to concentrate our cleaning activities in the most vital areas of the campus, we must institute the following operational and scheduling changes in building service.

- 1) Trash containers, except in lounges and vending areas, will be emptied once a week.
 - Please restrict eating and drinking in classrooms.
 - To minimize potential problems with ants, roaches, etc., please dispose all food-related trash in the trash containers located in lounges and vending areas.
- 2) Vacuuming of offices, office suites, conference rooms, and reception areas will be done once a week.
- 3) All requests for office moves will be scheduled only on the second and fourth Tuesday of each month as follows:
 - Small moves (two office maximum) will be done by the building services staff.
 - All other moves will be done by contract movers.
 - Moves involving situations off campus will be done by contract movers.
 - Moves will be scheduled on a first-come/first-served basis.
 - To have a move scheduled, please call the work management center at x5223.
- 4) In those situations where furniture and/or equipment must be picked up off campus, call central receiving at x5268.
- 5) Daily service of classrooms, restrooms, lounges, vending rooms, and locker rooms will not be changed.
- 6) The schedule for servicing the recycling containers will not be changed.

Subject: Contracts signed after services are rendered per comptroller's memorandum No. 11, Dec. 18

Section 287.058(2) of the Florida Statutes, requires that, except in the case of a valid emergency as certified by the agency head, for contracts for contractual services costing in excess of the threshold of category one (i.e. \$5,000); a written agreement shall be signed by both parties prior to the rendering of the services. It further provides that if this requirement is not met, the agency head shall, within 30 days after the contractor begins rendering the services, certify the conditions and circumstances which caused the noncompliance and describe the corrective action taken to prevent a recurrence of the noncompliance.

If the reasons stated above are not met, the only legal basis for making payment for the services is a settlement agreement, where the agency and the contractor agree, which must be approved by the state comptroller's office in accordance with instructions provided in comptroller's memorandum No. 4 (1987-88) in order to process payment for services rendered.

A number of requirements are needed to be provided according to comptroller's memorandum No. 4, as follows:

- A description, with appropriate supporting documentation, of the transactions or events that created the claim against the agency;
- A brief explanation of why the settlement is in the state's best interest under the circumstances;
- Copies of the notices required to be given the president of the Senate and the speaker of the House of Representatives pursuant to section 45.062, Florida statutes;
- A certification from the agency's chief financial officer that the proposed expenditure is provided for by an existing appropriation or program established by law as required by section 45.062, Florida statutes; and
- Any other information that the office of the comptroller may request in order to properly perform its duties pursuant to section 17.03, Florida statutes.

The contractual services certification form has been developed to respond to the above requirements. This form is available from purchasing or finance and accounting.

In order to avoid any noncompliance problems, please abide by the contract rules that requires that a written agreement shall be signed by both parties prior to the rendering of the services. If you have any questions, call purchasing, x2661, or finance and accounting, x2541.

Subject: Virus detection

A fast-moving, highly-destructive computer virus called Michelangelo is spreading among IBM-compatible personal computers. Michelangelo is set to strike on Friday, March 6, erasing vast amounts of information, causing disk directory damage and hard drive reformatting.

The virus has infected half of the PCs tested at the University of Florida, and all of the PCs at Southeastern Louisiana University. The Michelangelo virus has been found here at UCF. Don't risk losing important files and information; check your PC for possible virus contamination. Viruses are easily transferred from one PC to another with infected disks. An infected disk can come from a store, a co-worker, a friend or over the telephone lines.

Michelangelo can be detected using IBM's Scan ver. 2.1. You may obtain a free copy of this virus detection software from the computer services help desk. Simply bring a blank unformatted diskette to the help desk and we will provide you with IBM's Scan program and instructions for use. If a virus is detected, we ask that you contact the help desk immediately to make arrangements for one of our technicians to remove the virus from the PC(s).

The help desk is located in the computer store building (adjacent to the biology building) in room 104. If you have any questions regarding the virus, please do not hesitate to contact the help desk, x5117.

I regret to report to you that Gov. Lawton Chiles has signed SB2408 which eliminates funding for the 1991-92 salary increases scheduled to be implemented Feb. 14. As a result, employee salary increases which were authorized in the 1991-92 salary increase guidelines for faculty, A&P, and USPS employees are not to be provided. The only exceptions are the increases provided to USPS professional health care classes and developmental research school instruction faculty on Jan. 1.

I know this news will be greeted with varying emotions: dismay, frustration, even anger. But I also know that we will all continue to perform our duties and carry out our responsibilities to the best of our abilities, just as we have done this past year. What we are about as this university is a good thing, and we won't turn our backs on it.

and staff, saying that with their help, the university managed to accomplish many feats while he was interim president. The budget crunch has been difficult, he said, but university employees have worked extra hard to keep UCF afloat.

"State employees are not lazy," Bryan said, rebuking those who say

otherwise. "They've done an excellent job. They've kept (UCF) going, running."

Looking up from the podium, Bryan said his final good-bye.

"It's been a great time," he said. "God bless all of you."

Bryan guided UCF through one of the most difficult times in its history: the resignation of Steven Altman and state budget cuts that sliced into university spending.
