SANDSPUR SUPPLEMENT

The following resolution was tabled at the Assembly meeting of May 7, 1970.

RESOLUTION TO ESTABLISH A PRESIDENT'S SUMMER FUND

Be it resolved that:

(1) A President's Summer Travel Fund be established as a permanent fund of the Student Association, a fund for the purpose of financing the President's travel to and from, and attendance at, conferences and conventions which may occur in the course of a summer and from which the Student Association may benefit through its President's participation therein.

(2) Said Fund be allocated from the General Fund of the Student Association and be determined annually upon recommendation by the President in the Winter Term for the summer of that same calendar year.

(3) Should the President be unable to attend, the Vice President or other authorized representative of the President attend in the President's place.

(4) The President, or whosoever may attend in his place, be required to render to the Student Government at its first meeting in the Fall Term, a report on the proceedings of any such conventions as he may have attended in the course of the summer preceding, and on the ideas gained therefrom.

(5) \$450.00 be allocated for said Fund for the summer of 1970.

The following amendments to the Bylaws of the Student Association were tabled at the Assembly meeting of May 7, 1970.

Article 1, Section 2.

Amend by addition:

"provided they are also recognized by the Assembly. The Assembly recognition shall be by majority vote".

Article 1, Section 3.

Delete:

"or organizations"

Substitute:

"or social organizations, or any other groups",

The following motion was tabled at the Assembly meeting of May 7, 1970.

That the Student Center Board of Directors be allowed to re-allocate its unexpended funds at the end of the year, towards the refurbishing of the Student Union building.

The following motion was tabled at the Assembly meeting of May 7, 1970.

That the Student Association allocate not more than \$500.00 to be sent to an organization designated by the Assembly as a memorial fund in honor of the six students killed and those wounded at Kent State University.
